Therefore following definition of terrorism by Gibbs (in Turk, 2004, p. 284) will be used in this paper: Terrorism is threatening, perhaps illegal, clandestine (avoiding conventional warfare) violence against human or nonhuman objects that is intended to change or maintain some belief, law, institution, or other social "norm" by inculcating fear in persons other than the immediate targets. Gibbs, therefore, considers an attempt for social control as a possible base for explanatory theory (Turk, 2004). Johnson (1994 in Crenshaw, 2000, p. 415) states how the loss of order and control leads to an exaggeration of the likelihood of such an attack. Destabilizing society by shattering its moral values is used to put forward a political message.
